This Policy excludes liability arising out of or in connection with molestation and/o sexual abuse of any kind whatsoever **Subject otherwise to the Terms Conditions Limitations and Exclusions of the Policy**

AUTOMATIC ACQUISITIONS EXTENSION

(a) This Policy extends to include cover for new archery clubs and/or entities newly formed (including joint ventures) and/or acquired by the named insured during the Period of Insurance, provided always that:

- (1) there is no material change in the Insured's business activities
- (2) the turnover of such new club newly formed or acquired entities or joint ventures does not exceed 10% of the Insured's turnover at inception, and
- (3) the new entity/club has had no known or reported losses last 5 years

If new clubs, newly formed or newly acquired entities fall outside the criteria mentioned in (a) (1), (2) or (3) above then the Policy will not automatically extend to include such entities. The Insurers may agree to vary the Policy to provide cover in respect of such entities on such terms and conditions as the Insurers may determine (including in respect of additional premium).

TERRORISM EXCLUSION ENDORSEMENT

Notwithstanding any provision to the contrary within this insurance or any endorsement thereto it is agreed that this insurance excludes liability for loss, injury, damage, cost or expense of whatsoever nature directly or indirectly caused by, resulting from or in connection with any act of terrorism regardless of any other cause or event contributing concurrently or in any other sequence to the loss.

For the purpose of this endorsement an act of terrorism means an act, including but not limited to the use of force or violence and/or the threat thereof, of any person or group(s) of persons, whether acting alone or on behalf of or in connection with any organisation(s) or government(s), committed for political, religious, ideological or similar purposes including the intention to influence any government and/or to put the public, or any section of the public, in fear.

This endorsement also excludes loss, injury, damage, cost or expense of whatsoever nature directly or indirectly caused by, resulting from or in connection with any action taken in controlling, preventing, suppressing or in any way relating to any act of terrorism.

If the Insurers allege that by reason of this exclusion, any loss, injury, damage, cost or expense is not covered by this insurance the burden of proving the contrary shall
